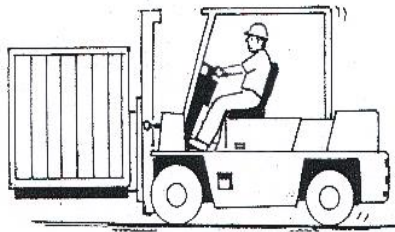

THEORY & PRACTICAL

The Competency Unit (CU) "Operate Forklift" applies to operating forklift in various environmental conditions and it covers the Competency Elements (CE) as listed below:

- CE2 : Inspect Forklift
- CE3 : Carrying Out Forklift Operations
- CE4 : Reinstate and Handover Forklift

^ENTRY REQUIREMENTS / *ASSUMED SKILLS AND KNOWLEDGE

- ✓ ^At least 18 years of age
- ✓ ^Singaporeans, Permanent Residents or Holders of valid employment pass / work permit
- ✓ *Employability Skills System (ESS) Workplace Literacy and Numeracy (WPLN) Level 3 and above, or equivalent
- ✓ *Be physically and mentally fit for the training, without any handicaps
- ✓ *Able to interpret work instructions and technical information

Note :

- *Proof of highest education certificate is recommended*
- *Those 70 years and above must produce a medical certificate of physical fitness*

WSQ OPERATE FORKLIFT (OFL3)

FOR WHOM

Learners who are required to operate a Forklift and possess a valid LTA Class 3 Driving License

They are required to attend a 3 days or 5 evenings course (which consists of 8hrs theory and 14hrs practical lesson).

COURSE ASSESSMENT

Forklifts are powered industrial trucks used to lift and transport material. However, improper operations can turn it into a lethal weapon. The operator are therefore expected to have the ethic of working safely in all circumstances to prevent workplace accidents.

FOR WHOM

For all qualified forklift drivers who require to refresh their safety knowledge and maintaining safe driving manners in forklift operation every 3 years according to Singapore Standard SS 573:2012.

OBJECTIVE

This refresher course aims to refresh the existing forklift drivers with all the safe driving habits and to reinforce the adherence of all the safety rules and guidelines when operating the forklift, hence prevent workplace accidents.
